Communicating the Rationale to Parents: Why We Use Starlight

That's why we are adopting **Starlight**, a professional coaching platform that allows teachers to **record audio of their lessons** and receive **confidential feedback** on how to improve and reflect on their teaching.

This is no different from how athletes or musicians use recordings to reflect on their performance and improve their craft. By supporting teachers in this way, we can enhance engagement, student understanding, and classroom dialogue.

Key Points to Communicate with Parents

- No students are identified in the Starlight system. The recordings are used solely for the purpose of teacher development.
- Audio files are transcribed using secure, GDPR-compliant systems, and no names or personal information are included in any analysis or report.
- Teachers are instructed never to upload sensitive or personal conversations. The system is designed to review teaching practice, not student data or behaviour.
- Participation in this system is a **professional right of staff** seeking ongoing, high-quality feedback and reflective practice.
- All audio recordings and transcripts are **fully anonymised** and **stored securely**, with teachers retaining the right to delete their recordings at any time.

Internal Message to Staff (for transparency)

"Never upload audio recordings that contain sensitive, personal, or confidential conversations. Ensure that all shared content is appropriate for professional review."
